

2023-2024 Tuition and Fees Schedule

Application: Any new student: \$100 application fee (per child) payable at time of application (non-refundable.)
Any returning student: \$100 re-enrollment fee (per child) due by February 26 (non-refundable).

Multi-child discount: For families with more than one child enrolled, full tuition is charged for the more expensive tuition, while each additional child in the family receives a 5% discount.

Security deposit: A security deposit is required of all families enrolled in the SMART tuition payment plan each year. The security deposit is equivalent to one month's tuition for each student enrolled for the upcoming academic year. **The security deposit is applied to May's Smart Tuition bill.** If a student withdraws during the year, the security deposit is applied toward any outstanding tuition and fees.

Financial Aid: Financial aid is available to families who meet criteria established by MHCA. More information is available at the office. Financial aid is applied as final payment on tuition.

* September supplies, textbooks, yearbook, select PE clothing (1st – 8th Grade receive one pair of gym shorts and one short-sleeved tee shirt for students enrolled by July 15th/sizes *must be provided by July 15th to ensure beginning of school delivery*), supply and lab fees included in full-year tuition.

Extended day: We offer an extended day program on a daily basis. The rates are: **\$4** for the first ½ hour; **\$8** for each 31-60 minutes thereafter. Extended day is offered from 7:00 – 8:00 a.m. and 3:00 – 5:30 p.m. Monday – Friday (Extended Day is not offered in the afternoon on ½ days or mornings with a delay).

After-School Late Pick Up Policy

The MHCA Extended Day Program closes at 5:30 PM. Students picked up after 5:30 PM are considered a late pick up, which will result in a late pick-up fee being assessed to your account. The late fee is \$1.00 per minute per child. It is important to have an alternate person lined up that you can call as a back-up plan in the event you are going to be late. Not only do children become hungry by this time, they become stressed and anxious when they realize everyone has been picked-up and no one has arrived for them. We are also committed to our staff, as they have responsibilities to their own families and ministries after school. Please make every effort to pick up your children on time.

Note: Tuition paid in full by June 1 will receive a 3% discount. SMART Tuition Management Services handles our tuition collection. You may have automatic withdrawal (ACH) from your account or monthly invoices. Enrollment in SMART is \$50 yearly. SMART payments are due the 10th/15th or 30th of each month from June through May. SMART charges \$60 in fees (a late fee of \$20 for payments received 10 or more days after the due date + \$40 for following up with parents on late payments). SMART also charges \$30 for each check returned for insufficient funds and \$30 for each returned ACH deduction. SMART's current credit card convenience fee is 2.65% of the payment amount. MHCA imposes a \$30 fee for checks issued to the Academy which are returned for insufficient funds.

Any student withdrawn during the school year must contact the school office in writing 30 days prior to the effective date of withdrawal. In the event of withdrawal prior to August 15, parents will be responsible to pay 2 monthly payments to cover the cost of materials already purchased for the student. If the student withdraws prior to December 31, parents are responsible for half tuition. If the student withdraws after December 31, parents are responsible to pay for the remainder of the annual tuition. (The MHCA Board of Directors reserves the right to make exceptions to this policy on a case-by-case basis).
